#### Service Restriction:

Unit Certification is not required for this product. If the manufacturer or purchaser request an ABS Certificate for compliance with a specification or standard, the specification or standard, including inspection standards and tolerances, must be clearly defined. Coupling types with tapered threads are not to be used for toxic and corrosive fluid services and for all services of temperatures exceeding 495°C. In classes I and II piping systems in general, for joining sections of hydraulic pipes and for steering gear-, controllable pitch propeller-, and propulsion related hydraulic systems their use is limited to the following restrictions:

Pipe OD (mm): 6-20, Pressure Limitation (bar): 103, Pipe OD (mm): 22-25, Pressure Limitation (bar): 82.8, Pipe OD (mm): 28-42, Pressure Limitation (bar): 41.4.

In other hydraulic oil systems they may be used without pressure limitation only for connection to equipment, such as pumps, valves, cylinders, accumulators, gauges and hoses. Straight thread O-ring type fittings may be used for connections to equipment in hydraulic oil piping without pressure limitation, but are not to be used for joining sections of pipes. Generally, care is to be taken to prevent build-up of static electricity in piping conveying fluids having flash point of 60°C or less or being routed through hazardous areas. Threaded couplings are not to be used in Class A/B Divisions and watertight bulkheads.
